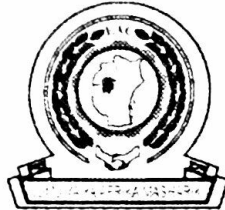

1. This Act may be cited as the East African Community Supplementary Appropriation Act, 2014 and shall be deemed to have come into force on the 1st day of July, 2013.
