# An Act to make supplementary appropriation out of the East African Community Budget to the service of the financial year ending 30th June, 2015.

Date of assent: 22nd April, 2017.

Date of commencement: 1st July, 2014.

ENACTED by the East African Community and assented to by the Heads of State

**1.** This Act may be cited as the East African Community Supplementary Appropriation Act, 2019 and shall be deemed to have come into force on the 1st day of July, 2014.

2. Supplementary appropriation of the sums specified in column 2 of the Schedule is hereby allowed out of the East African Community budget in respect of the financial year ending 30th June, 2015, for the purposes and activities specified in column 1 of the Schedule.
