LAYING OF PAPERS

LIST OF MEMBERS OF THE FIFTH EALA

The Clerk (Mr Alex Lumumba Obatre): Honourable Members, my name is Alex Lumumba Obatre, the Clerk of the East African Assembly (EALA). I will take you through the process in line with the Rules of Procedure of the Assembly as prescribed by law.

Honourable Members, pursuant to the provisions of Rule 5 of the Rules Procedure of the Assembly, the Clerk is required, on the first day of the new House, to read out aloud and lay on the Table the list of Members of the House, as transmitted to the Clerk by the Speakers of the National Assemblies of each of the Partner States in accordance with Section 5 of the East African Legislative Assembly Elections Act, 2012.

I confirm that the seven Partner States of the East African Community (EAC), through their respective Speakers, transmitted to me the list in accordance with the law. Therefore, I will proceed to read out in alphabetical order of the countries, the list of names as sent to me. The list is, as received and as *gazetted* by me, under Legal Notice: EAC/418/2022, Members of the Fifth Assembly.

Pursuant to Article 1 of the Treaty for the Establishment of the EAC, whereas Article 48 of the Treaty provides:

- (1) "The membership of EALA shall comprise-
- (a) nine members elected by each Partner State; and
- (b) *ex-officio* members consisting of:
- (i) the Minister responsible for East African Community affairs from each Partner State; and
- (ii) the Assistant Minister or Deputy Minister or Minister of State responsible for East African Community affairs from each Partner State:

Provided that an Assistant Minister, Deputy Minister or Minister of State may only participate in the meetings of the Assembly when the substantive Minister responsible for East African Community affairs is for any reason unable to participate; and

(iii) the Secretary General and the Counsel to the Community."

Whereas Article 50 of the Treaty provides that:

"The National Assembly of each Partner State shall elect, not from among its members, the nine members of the Assembly, who shall represent as much as it is feasible, the various political parties represented in the National Assembly, shades of opinion, gender and other special groups in that Partner State, in accordance with such procedure as the National Assembly of each Partner State may determine."

Recognising that the Clerk of the East African Assembly has in accordance with Section 5 of the East African Legislative Assembly Elections Act 2012, received the names of Members of the Assembly elected by each Partner State;

The Clerk: I wish to confirm that this is the list as transmitted to me by the Speakers of the EAC National Parliaments of the elected members. In accordance with Rule 5 of the Rules of this House, I beg to lay on the Table the list as prescribed by the Rules.

Honourable Members and distinguished invited guests, the membership of the Assembly includes *ex-officio* members. Our Treaty in Article 48 provides for that. It is now my duty to read out the list of names of the *ex-officios* as it stands today. The membership is never complete without the *ex- officio* members. Under Article 48(1), this is already provided for.

Whereas Article 48 of the Treaty provides that the membership of the East African Legislative Assembly shall comprise:

- "(a) nine members elected by each Partner State; and
- (b) *ex-officio* members consisting of:
- (iv) the Minister responsible for East African Community affairs from each Partner State; and
- (v) the Assistant Minister or Deputy Minister or Minister of State responsible for East African Community affairs from each Partner State:

Provided that an Assistant Minister, Deputy Minister or Minister of State may only participate in the meetings of the Assembly when the substantive Minister responsible for East African Community affairs is for any reason unable to participate; and

(vi) the Secretary General and the Counsel to the Community."

And, whereas Article 50 of the Treaty provides for the National Assembly of each Partner States to elect, not from amongst its members the nine members to represent the Partner States; which I have already done,

ADMINISTRATION OF OATH

Aware that this item on administration of oath has already been called out, honourable members, Section 8 of the Oaths Act, 2019 requires each Member of the Assembly to take oath in the first sitting. Our Rules of the Assembly further requires that you can only sit or vote in the Assembly after taking the oath of affirmation of allegiance to the Treaty. That is specifically in Rule 5(4).

Aware that you are lined up to take important activities after administration of oath, Rule 5 requires the Clerk to administer the oath of affirmation or allegiance to the Members.

Allow me to thank the former Vice President of the Republic of Kenya and the spouse of the Prime Minister of the Republic of Kenya for gracing this occasion. -(Applause).
