Good morning!

- It is for me a great honor and privilege to join you, in this Lilongwe beautiful city, at the 51st SADC Parliamentary Forum Plenary Assembly Session.
- At the outset, I congratulate Your Excellency for the continued leadership and wish you well in your endeavor.
- I also congratulate Rt.Hon. Catherine Gothani-Hara and the Parliament of Malawi for hosting this Plenary Session.
- In the same spirit, I wish to extend my deep appreciation to Rt. Hon.
 Christophe Mboso N'Kodia Pwanga, President of SADC Parliamentary Forum and Speaker of the National Assembly of the Democratic Republic of Congo, the entire membership of the SADC PF for the invitation to your 51st Plenary Assembly.
 I present to you all, the compliments of my colleagues, members of the East African Legislative Assembly (EALA).
- Ladies and Gentlemen, allow me at this juncture to commend SADC PF for choosing to place this Plenary Session under such important theme:
 "Towards energy efficiency, sustainability and self-sufficiency in the SADC Region", at a times when we are experiencing a rise in prices of oil and gas caused by factors far away from our continent.
- As a matter of fact, higher energy prices are digging into consumer wallets, leading to surge in inflation, and spill over to the costs of broad goods and services as a result of higher production and transportation costs.
- Unfortunately, these negative effects overburden low-income households who form the majority of our electorate, the people that, we, Parliamentarians represent at national and regional levels.

- action for enhanced access to sustainable energy if our regions and the people we represent are to attain the UN 2030 Agenda for Sustainable Development Goals, especially Goal 7 which calls for "affordable, reliable, sustainable and modern energy for all" by 2030. In this endeavour, our action should be guided by the Global roadmap to secure clean energy access for all by 2030 and net zero emissions by 2050, issued by UN Secretary-General as a result of the UN High-level Dialogue on Energy held on 24 September, 2021 (which was attended by over 130 Heads of State and Government and global leaders from business and other sectors).
- **Distinguished Members, Ladies and Gentlemen,** permit me to share the actions we have undertaken in the EAC region to strengthen our regional cooperation in the energy sector. Under Article 101 of the Treaty (for the Establishment of the EAC), Partner States agreed to adopt policies and mechanisms to promote the efficient exploitation, development, joint research and utilisation of various energy resources available within the region. In the implementation of the Treaty provision, the EAC has:
 - i) developed a Regional Power Master Plan including cross-border electrification, interconnection and hydropower projects such as the Kikagati/Murongo Hydropower project (24 MW) between Tanzania and Uganda, Karuma power plant in Uganda (600 MW), Rusumo falls hydropower project (80 MW) between Burundi, Rwanda and Tanzania, Nshongezi hydropower project (54MW) between Uganda, Tanzania and Rwanda and Ruzizi hydropower project (124 MW) between Burundi, Rwanda, and Congo DRC.
 - *ii)* constructed **cross-border power transmission lines** such as the Kenya-Tanzania (Rongai-Kilgoris-Mwanza 400 KV transmission line which is part of Lake Victoria transmission ring).

iii) undertaken cross-border oil and gas pipeline projects such as Kenya-South Sudan development of Lamu-Isiol0-Juba crude oil pipeline and the Uganda-Tanzania development of crude oil export pipeline of 1443 km.

Once these projects are fully implemented, they will greatly enhance our regional access to energy and contribute to reducing our dependency to foreign energy markets.

- As you discuss about SADC region self -sufficiency in energy supply, be assured of our support and the readiness of the EAC to partner with you in this endeavour.
 - To that effect, we should explore joint actions to be undertaken within our traditional roles of legislation, representation and oversight.
- **Distinguished Ladies and Gentlemen,** with these few remarks, once again, I thank you for the invitation extended to EALA, and wish you a fruitful symposium and 51st Plenary Assembly Session.
