THE EAST AFRICAN COMMUNTY SUPPLEMENTARY APPROPRIATION ACT, 2016

An Act to make supplementary appropriation out of the East African Community Budget to the service of the financial year ending 30th June, 2016.

ENACTED by the East African Community and assented to by the Heads of State

1. This Act may be cited as the East African Community Supplementary Appropriation Act, 2016 and shall be deemed to have come into force on the 1st day of July, 2015.
