





1. This Act may be cited as the Acts of the East African
Community (Amendment) Act 2009 and shall come into effect
on publication.

2. Section 2 of the Acts of the Community Act, 2003
herein referred to as the “principal Act” is amended by
replacing the definition of the word “session” with the
following “session” means a series of meetings of the
Assembly commencing when the Assembly first meets in any
year and terminating on the same date in the following year.

3. The opening statement of Section 7 (1) of the
principal Act is replaced as follows “The Heads of State may
within three months from the date on which a Bill has been
passed by the Assembly—”
