1. This Act may be cited as the East African Community Citation and Appropriation Act, 2007 and shall be deemed to have come ment into force on the 1st day of July, 2007.

2. The Secretary General may issue out of the budget of Issue of the East African Community and apply towards the supply granted to the Community for the services of the year ending on the 30th June, 2008, the sum of United States Dollars Twenty Eight Million Three Hundred Thirteen Thousand, Five Hundred Fifty Nine.

Appropriation of sums granted

3. The sums granted by this Act shall be appropriated for the services and purposes specified in the Schedule to this Act.

Payment for services in previous financial year 4. Any part of the sums granted by section 2 which has been, or is issued from the budget of the East African Community before the 30th June, 2008 shall be available until a date to be determined by the Council of Ministers, not being later than the 31st day of December, 2008 for making payments which become due during the year ending on the 30th June, 2008.
