Payment for services in previous financial year 4. Any part of the sums granted by section 2 which has been, or is issued from the budget of the East African Community before the 30th June, 2009 shall be available until a date to be determined by the Council of Ministers, not being later than the 31st day of December, 2009 for making payments which become due during the year ending on the 30th June, 2009.
